- 4. Obligation and rights are not limited to the tenancy but also common areas. We draw attention to the fact that it is the sub-lessee who is liable for all damages caused by the person concerned or their guests, and it applies to both fixtures inside the tenancy as well as in common areas. However, the dormitory will always hold the sub-lessor responsible for damages, and the sub-lessor is, thus, directed to claim the sub-lessee responsible. Besides, we refer to the original tenancy lease contract.
